

# An Overview of CPSI: Who we are, what we do

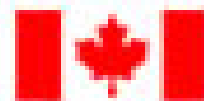

- Canada follows the federalist model of government
- 10 provinces/three territories
- In Canada, there are both federal and provincial/territorial quality and patient safety structures – usually institutes/councils

- Canada is governed through federal, provincial/territorial (13) and municipal structures
- The Constitution Act delineates power as between the Federal and Provincial/Territorial government
- Both the Provinces/Territories have income and property taxing authorities
- Federal government governs and funds health care in federal jurisdiction – police, armed forces, prisons and first nation bases
- Federal government partially funds health care in the Provinces and Territories through transfer payments but constitutionally the delivery of health care is governed by the Provinces/Territories

- Is a federal not for profit corporation formed through a cooperative agreement of all Federal and Provincial/Territorial governments with the intent of ensuring national cooperation and coordination of patient safety efforts (avoid duplication)
- All governments are “members” or “shareholders” of the corporation
- Board of Directors is partially appointed (by the government members) and elected through a call for nominations from all members

# Medication Communication Failures Impact EVERYONE!

## PATIENT & FAMILY



- loss of life
- prolonged disability
- temporary harm
- complicated recovery
- loss of income
- confusion about treatment plan

## HEALTHCARE SYSTEM



- prolonged recovery time
- increased cost and staff time due to rework
- avoidable readmissions and Emergency department visits
- reduced access to health services

## SOCIETY



- loss of productivity
- workplace absenteeism
- increased cost
- loss of public confidence in the healthcare system

## Medication Safety: We all have a role to play.

Safe patient care depends on accurate information. Patients benefit when clinicians work with patients, families, and their colleagues to collect and share current and comprehensive medication information. Medication reconciliation is a formal process to do this at care transitions, such as when patients enter the hospital, are transferred or go home. We all have a role to play.

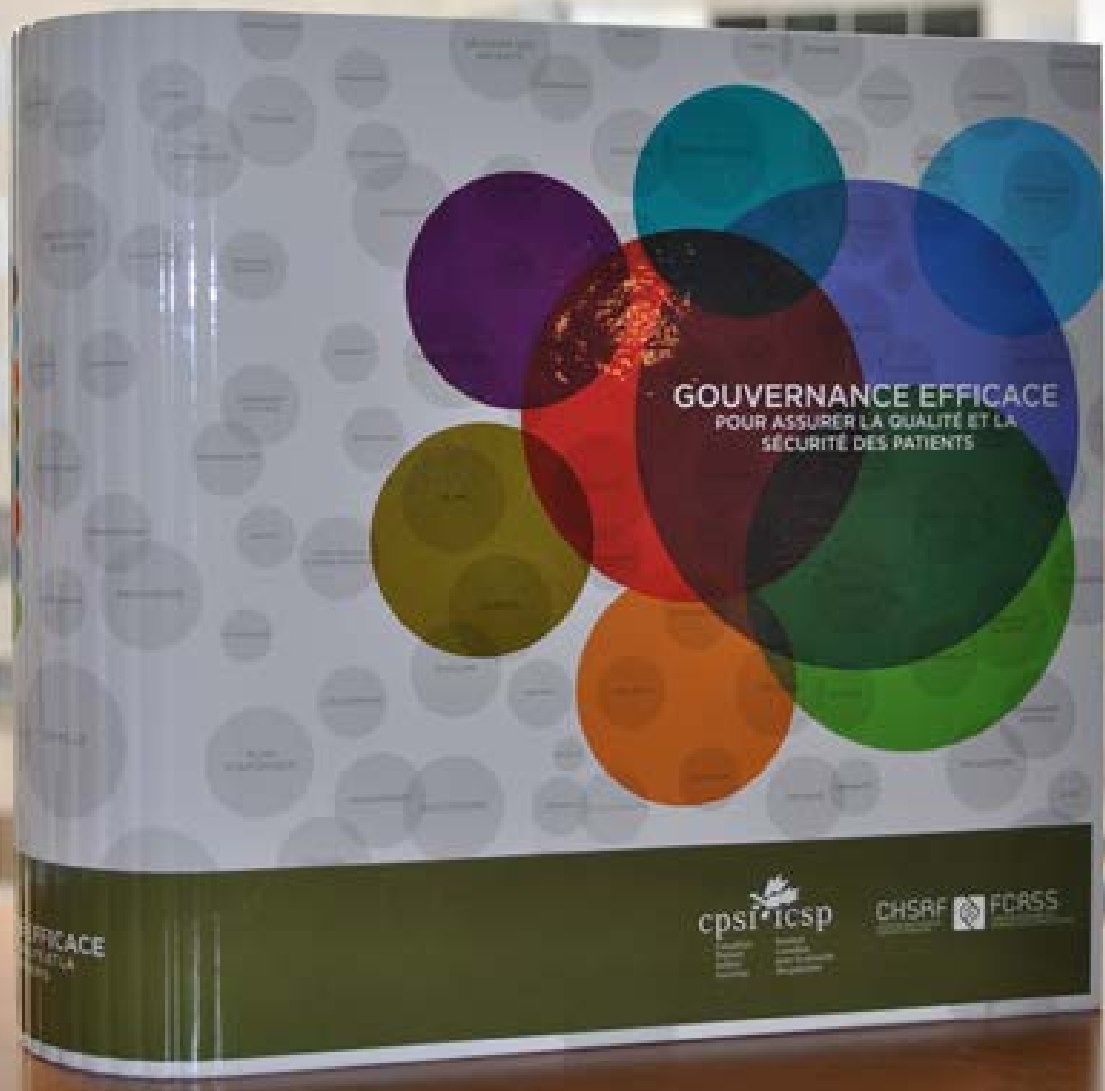

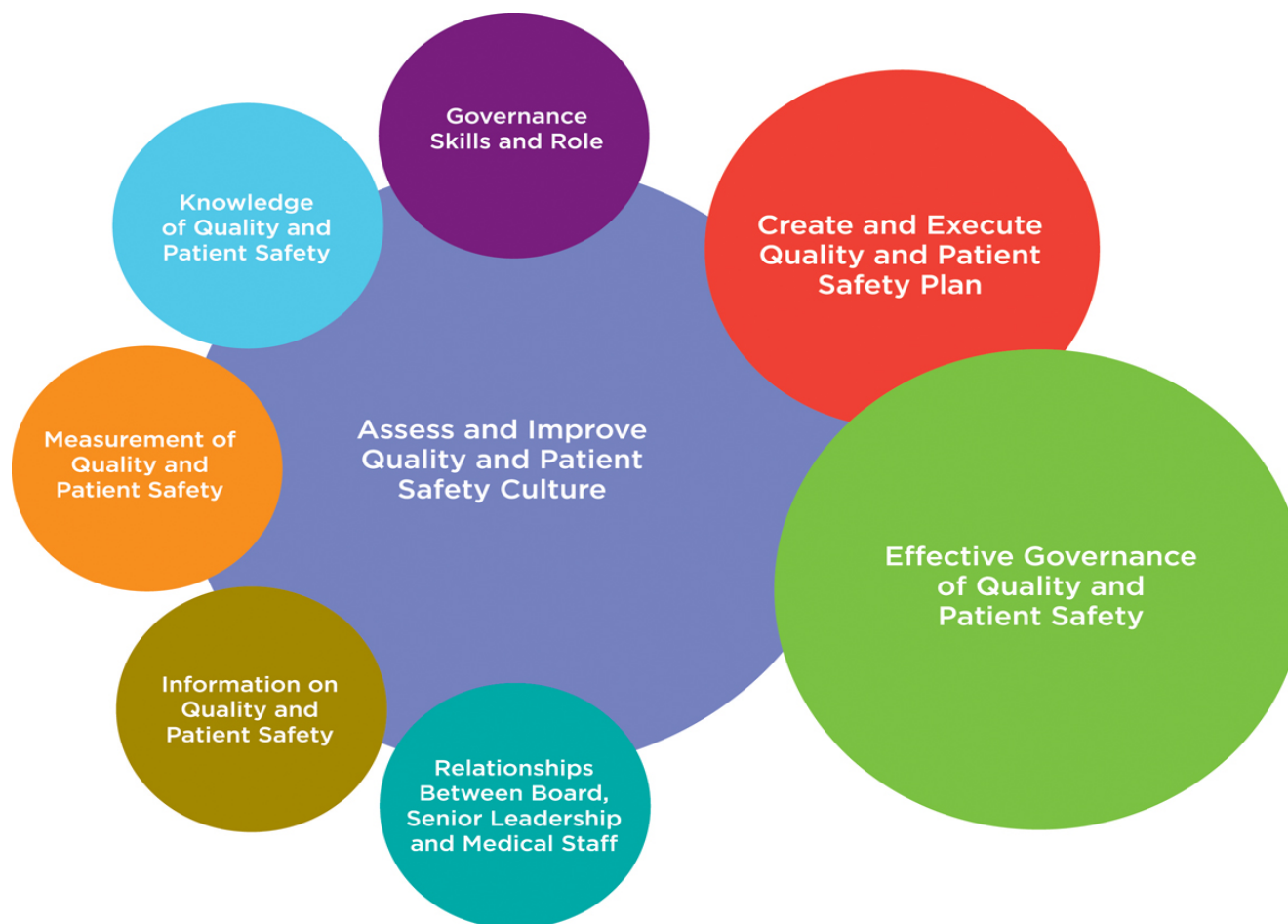

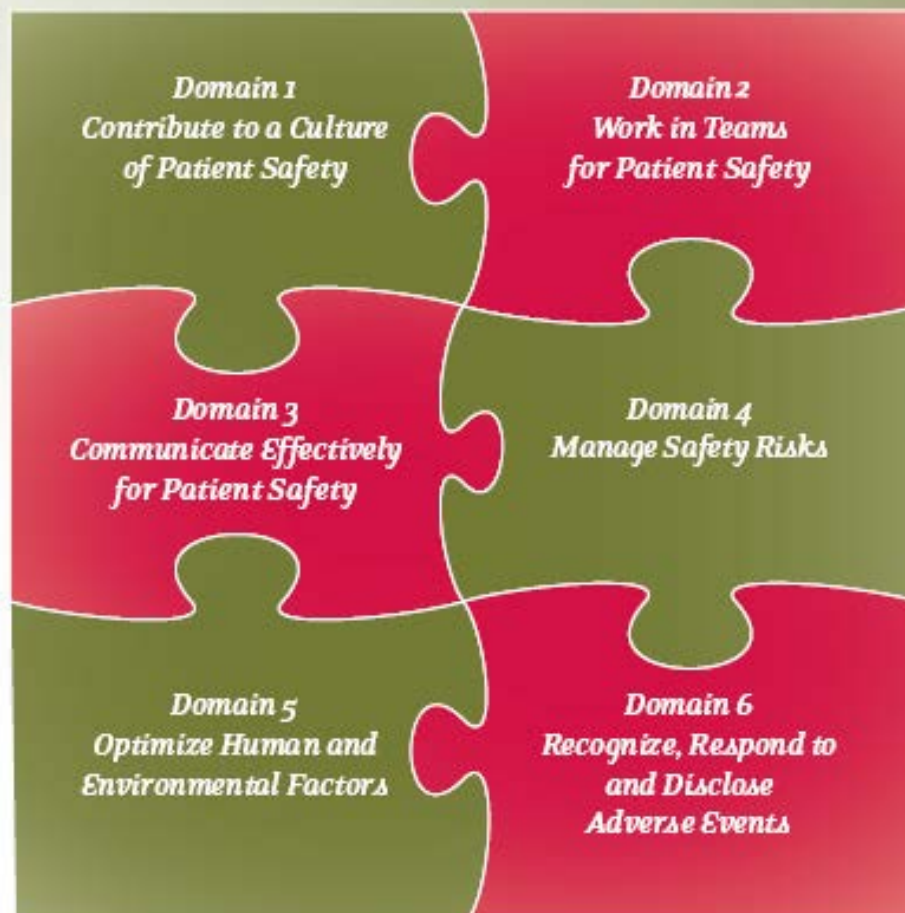
